Entries may be sent or delivered to Pro Camera, 618 Forest Street. All photos submitted will be judged and the winners will be displayed at the C&O Gallery and on the ASAP website, [www.asapnow.org](http://www.asapnow.org). The decision of the judges will be final. Prizes will be awarded at a ceremony at the C&O in late April.



## Prizes will be awarded in two categories:

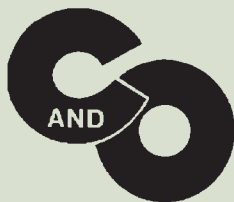
1. single photograph in black and white or color.

**Other contest rules and requirements:** All entrants agree to assign the copyright and all intellectual rights to their entries to ASAP for reproduction for publicity of the contest and promotion of ASAP's mission to include placement on their website, in their brochure, or on or in other promotional materials. All photographs must be submitted by 5 PM on April 6, 2007 and will be returned to the entrant if submitted with a stamped self addressed envelope. The limit is three entries per category per person. No photographs larger than 11 x 14 or smaller than 4 x 6 will be accepted for the contest. Photographs may be from film or digital images. Only minor "tweaking" of images is permitted with editing software. Winners may be asked to provide original slides, negatives or digital images in their original form. No more than 6 photos will be accepted for entry in the collage, sequence, before and after category. Gift certificates will be given in addition to cash prizes. Special prizes may be awarded at the discretion of the judges. An entry form that includes name, address, phone number, email address, and release of rights must be included with each entry. Entries will be accepted from amateur or professional photographers. ASAP's contest committee will be final arbiter of all conflicts regarding this contest.
